    - Also recommend replacement jumpers

  - Attempting to gain access to facility to investigate.
- 443.85 Offline
  - Repeater has been reinstalled; however, it appears to still have receive issues
  - Folded Dipole 8 bay antenna for the 440mhz would be the recommended new antenna to purchase
- New Trustee the FCC has not been updated, at this time. Also needing to update is QRZ. Need to post copy of the license at all repeater locations.
- Jason Lopez has been informed that he is welcome to utilize the 146.70 repeater for the Geist half-marathon event.
