- o <u>147.120</u> Trying to gain site access to reprogram controller [N9BA]
 - o MOU Needs to be written for the co-habitation of the IRA equipment w/ IPL
- 443.850 power amplifier needs to be reinstalled. IRA pre-amp needs a filter. W9BU has a pre-amp and filter that COULD be installed. Bob stated that he would like to eventually get a new controller to link the 443.850 and 146.700. Mike stated if we are going to do that we should probably look at a phone line to program it.
- W9BU Tower Work \$355.01 is still due to W9BU, Bob for past tower work.

New Business:

- Repeater Interference
 - Referencing W9ZEP, Michael Wagner. An "updated" ban letter has been sent to him, along with a copy to Riley Hollingsworth.
 - Riley Hollingsworth communicated with Mike, N9FEB as to whether we, as a Board, want the FCC to take action – N9FEB replied "YES".
- CERT would like to utilize the 147.120 Repeater for their Net on Monday's at 7:15pm when a Weather Situation calls for Skywarn to be using the 146.760. All agreed.

- Net Use; 146.700 Sat AM's 15-min
 - o Is AC9JX John Kassebaum a member? No, John is not an IRA member
 - John just would like to use the repeater for net purposes and has stated he would not want to utilize the repeater in the case of an emergency.
 - o The board voted to not allow this group to utilize our repeater for their net
