- Treasurer's report

Presented the 2020 income statement and balance sheet, as well as the 2021 income statement and balance sheet. No questions/comments from the attendees. Brent made a motion to accept the presentation, with the date correction. Noel seconded. All approve.

Carry-Over items

- <u>146.700</u> Current power Amp is 30+ years old. Thoughts on replacing it. We will need a new amplifier which runs about \$850. This is for a Henry 10W in 100W out continuous run. Bob [AK9R] believes the power supply at the site will handle it. Mike proposed since we need this if we want to cash out the CD maturing on 2.27.20 to do this. It was agreed to continue discussion next meeting since we have another CD maturing then. Since this date has passed, let's look at other options.
- <u>147.120</u> Trying to gain site access to reprogram controller [N9BA]
 - MOU Needs to be written for the co-habitation of the IRA equipment w/ IPL
- <u>443.850</u> power amplifier needs to be reinstalled. IRA pre-amp needs a filter. AK9R has a pre-amp and filter that COULD be installed. Bob stated that he would like to eventually get a new controller to link the 443.850 and 146.700. Mike stated if we are going to do that we should probably look at a phone line to program it.
- AK9R Tower Work \$355.01 is still due to AK9R, Bob for past tower work.

- New Business
 - On Dec 13, 2020, a letter was sent to all current members of the IRA. In this letter, it was summarized on the current status of all repeaters. It stated what had happened to the 146.700 "timed-out" situation and the "tone" being emitted from the 146.625; both have been corrected. Also, it described that being a paid-in-full membership prior to the Jan 25, 2021 General Membership Meeting was imperative in order to run for office or vote. This Annual Meeting will be via ZOOM, to include voting for replacement Board Members.

- ➢ Elections on Jan 25, 2021:
 - Expiring Board positions are: N9FEB, WS9H, and W9CYU
 - Mark [W9MGB] wishes to be replaced (he has 2-years left on his term)
 - According to By-Laws, Article II, Section 1, In the event of a mid-term vacancy, "a person shall be chosen at the next regular election to fulfill the remaining years of that term." The Board is to do this choosing from the list of candidates that wish to run for office. This shall be done <u>FIRST, BEFORE</u> voting to fill the other vacant positions.
 - Mike asked if there was anyone else who wishes to be a board member. No one spoke up.
 - The replacement for Mark who will serve a 2 year term John W9JS
